In order to be eligible to use the services provided by Camping du le Bois soleil and that your holidays are carried out in good conditions we ask you to take note of the general conditions of sale. These conditions govern the sale of holidays and take effect from the moment your booking is placed. By booking a holiday, you agree to fully comply with our general conditions as well as the rules of the campsite available.

1-Booking conditions

• The campsite offers family-oriented holidays, in the traditional sense, the accommodations are specially designed for this purpose. The campsite reserves the right to refuse any reservation that would be contrary to this principle, or that would seek to divert it.

• The booking of a camping pitch or rental is strictly personal. Under no circumstances may you sublet or assign your booking without the prior consent of the campsite. The contractor must be present for the duration of the stav.

Camping pitches

• The "COMFORT" pitch includes the location for 2 people the vehicle, access to sanitary, a caravan a tent or camper and electricity.

The capacity is 6 people. It is imperative to communicate to us at the reservation the detail of all the equipment to be installed during the stay

Renting

The campsite offers a wide choice of rental range from 2 to 8 people. The first number corresponds to the capacity recommended by the campsite and the second to the maximum capacity. The campsite will be obliged to refuse access to the campsite to incoming holidaymakers with a number of people exceeding the maximum capacity indicated. Failure to comply with this rule will automatically result in additional billing by the campsite. No installation (tent), vehicle or additional person is accepted on the location of rentals without agreement of the campsite.
